CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LOST AND BOULDER DITCH COMPANY

confirms the right to the use of water perfected under the terms of Permit S-25326. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point of diversion from the source. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: FOREST CREEK, A TRIBUTARY OF THE WHITE RIVER

PURPOSE OR USE: SUPPLEMENTAL IRRIGATION OF 19.8 ACRES

MAXIMUM RATE: 0.161 CUBIC FOOT PER SECOND

DATE OF PRIORITY: JANUARY 27, 1958

The point of diversion is located as follows:

Twp	Rng	Mer	Sec	Q-Q	Measured Distances
4 S	10 E	WM	27	SW SW	195 FEET NORTH AND 256 FEET EAST FROM SW CORNER, SECTION 27

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Any future appropriation under this right shall be limited to the following conditions:

- 1) At all times that water is diverted under the permit, 2.0 cubic feet per second of the natural flow of Forest Creek shall be passed by the point of diversion of the Lost and Boulder Creek Ditch Company.
- 2) The intent of this waiver is to provide 2.0 cubic feet per second of water in Forest Creek to flow through and service the Forest Camp, and shall not be effective if the Forest Camp is abandoned or future appropriations are allowed which do not contain the same provisions.

A description of the place of use is as follows:

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The right to the use of the water for the above purpose is restricted to beneficial use on the place of use described.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered August 25, 2014, at Special Order Volume 93, Page 292, approving Transfer Application T-11718, and together with Certificate 89478, supercedes Certificate 80560, State record of Water Right Certificates.
