confirms the right to use the waters of LOST AND BOULDER CREEKS, TRIBUTARIES OF THE WHITE RIVER for IRRIGATION of 19.8 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Wasco County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 7 and 11, at Page 196 and 416, respectively. The date of priority is 1901.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.26 CUBIC FEET PER SECOND, MEASURED AT OR NEAR THE DIVERSION BOX AT THE HEAD OF THE MAIN LATERALS OF SAID COMPANY SITUATED IN THE NE1/4 SW1/4, SECTION 10, T5S R11E, W.M.

The points of diversion are located as follows:


The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in the decree.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered August 25, 2014, at Special Order Volume 93, Page 292, approving Transfer Application T-11718, and together with Certificate 89479, supercedes Certificate 81335, State record of Water Right Certificates.
