## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LOST AND BOULDER DITCH COMPANY P.O. BOX 191 TYGH VALLEY, OREGON 97063

confirms the right to use the waters of LOST AND BOULDER CREEKS, TRIBUTARIES OF THE WHITE RIVER FOR IRRIGATION OF 0.3 ACRE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Wasco County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 7 and 11, at Page 196 and 416, respectively. The date of priority is 1911.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.007 CUBIC FOOT PER SECOND (CFS) UP TO JULY 1, AND 0.0035 CFS THEREAFTER, or its equivalent in case of rotation, measured at the point of diversion.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed ONE-FORTIETH OF A SECOND FOOT PER ACRE up to July 1 of each year and thereafter not to exceed ONE-EIGHTIETH OF A SECOND FOOT PER ACRE, except in case of rotation, further limited to a maximum diversion of 1.0 ACRE-FOOT PER ACRE during any 30 day period up to July 1 of each year and not to exceed 3.0 ACRE-FEET PER ACRE during any irrigation season.

The points of diversion are located as follows:

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in the decree.
