confirms a portion of the right to use the waters of MCKAY RESERVOIR, constructed under reservoir Permit R-584, a tributary of MCKAY CREEK, for SUPPLEMENTAL IRRIGATION of 89.0 ACRES.

A portion of this right was perfected under Permit S-7400. The date of priority is JULY 1, 1924.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) provided further that the right allowed herein for supplemental irrigation shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed therein.

The water user shall comply with the terms and conditions of a valid Water Contract between the Bureau of Reclamation and the water user.

The quantity of water diverted at the new additional point of diversion, together with that diverted at the original points of diversion shall not exceed the quantity of water lawfully available at the original points of diversion.

Water use measurement conditions:

- A. The water user shall maintain the totalizing flow meter or measuring device, as approved by the Director, in good working order, at each new point of diversion.
- B. The water user shall allow the watermaster access to the meter or measuring device; provided however, where the meter or measuring device are located within a private structure, the watermaster shall request access upon reasonable notice.

The water user shall operate and maintain the fish screen at the new point of diversion consistent with Oregon Department of Fish and Wildlife's (ODFW) operational and maintenance standards. If ODFW determines the screen is not functioning properly, and is unsuccessful in working with the water user to meet ODFW standards, ODFW may request that the Oregon Water Resources Department (OWRD) regulate the use of water until OWRD receives notification from ODFW that the fish screen is functioning properly.

This certificate is issued to confirm a change in PLACE OF USE AND AN ADDITIONAL POINT OF DIVERSION approved by an order of the Water Resources Director entered May 3, 2016, at Special Order Volume 100, Page 373, approving Transfer Application T-11738, and modifies a portion of the right perfected under Permit S-7400.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
