CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

S.L. MAGILL
LOSTINE OR 97857

confirms the right to use the waters of the SOUTH FORK OF WALLOWA RIVER (LOSTINE RIVER), a tributary of WALLOWA RIVER for IRRIGATION of 379.0 ACRES, DOMESTIC AND STOCK USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Wallowa County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 5, at Page 181. The date of priority is 1891 FOR TRACT NO. 1, 1896 FOR TRACT NO. 2, AND 1889 FOR TRACT NO. 3.

The amount of water to which this right is entitled is limited an amount actually beneficially used for said purposes, and shall not exceed 1 1/2 acre feet per acre during any period of 30 days prior to July 31st of each year, and thereafter not to exceed 1.0 acre foot per acre during the entire remainder of the irrigation season; and said right shall be subject to all other conditions and limitation contained in said decree.

A description of the place of use to which this right is appurtenant is as follows:
