This right was perfected under Permit S-37150. The date of priority is JULY 25, 1973, plus one minute. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 3.15 CUBIC FEET PER SECOND, and is further limited to 1,532.94 ACRE FEET per year measured at the point of diversion, from MARCH 1 through OCTOBER 31.

The description of the point in which flows are to be maintained is as follows:

Water rights upstream of the original point of diversion shall not be subject to regulation for flows in excess of the quantity to which this instream water right is entitled at the original point of diversion.

Within the specified stream reach, the amount of water to which this right is entitled shall not exceed the quantity of water legally available at the original point of diversion.

The instream right established by this transfer shall replace a portion of instream water rights established pursuant to ORS 537.341 or 537.346 and shall be in addition to instream water rights
