CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

STATE OF OREGON
WATER RESOURCES DEPARTMENT

confirms the right to use the waters of the COLUMBIA RIVER, tributary to the PACIFIC OCEAN, for instream use for conservation, maintenance and enhancement of aquatic and fish life, wildlife, fish and wildlife habitat and other ecological values.

This right was perfected under Permit S-37150. The date of priority is JULY 25, 1973, *plus one minute*. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 3.15 CUBIC FEET PER SECOND, and is further limited to 1,532.94 ACRE FEET per year measured at the point of diversion, from MARCH 1 through OCTOBER 31.

The description of the point in which flows are to be maintained is as follows:

At the location of the diversion previously authorized under Certificate 79482:

Water rights upstream of the original point of diversion shall not be subject to regulation for flows in excess of the quantity to which this instream water right is entitled at the original point of diversion.

Within the specified stream reach, the amount of water to which this right is entitled shall not exceed the quantity of water legally available at the original point of diversion.

The instream right established by this transfer shall replace a portion of instream water rights established pursuant to ORS 537.341 or 537.346 and shall be in addition to instream water rights

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW



Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The right is subject to all other terms and conditions of Certificate 95154 and any related decree.

This certificate is issued to confirm an ALLOCATION OF CONSERVED WATER approved by an order of the Water Resources Director recorded in Special Order Volume 120, Page 1166, approving Conserved Water Application CW-119. This Certificate together with Certificates 95659 and 95660, and the conserved water under CW-119, supersedes Certificate 95154, State Record of Water Right Certificates.
