## CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of A WELL a tributary of FORT ROCK BASIN for the purpose of IRRIGATION of 205.2 ACRES.

This right was perfected under Permit G-8199. The date of priority is APRIL 27, 1978. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 2.56 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.
