confirms the right to use the waters of NORTH YAMHILL RIVER, tributary of the YAMHILL RIVER for IRRIGATION OF 20.0 ACRES.

This right was perfected under Permit 13288. The date of priority is SEPTEMBER 14, 1938. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.25 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.
