CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

PINE LAKES DITCH AND RESERVOIR COMPANY
 46350 HWY 86
 HALFWAY OR 97834

confirms the right to the use of waters of PINE CREEK AND EAST LAKE RESERVOIR constructed under Permit R-2309, a tributary of the SNAKE RIVER for IRRIGATION OF 61.4 ACRES AND SUPPLEMENTAL IRRIGATION OF 38.7 ACRES.

This right was perfected under Permit S-26491. The date of priority is OCTOBER 7, 1959. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.29 cubic feet per second from PINE CREEK and a portion of the 42.5 acre-feet (AF) from EAST LAKE RESERVOIR, or its equivalent in case of rotation, measured at the point of diversion from the source. The portion of stored water allowed for this right, together with the portion allowed under Certificate 88924 shall not exceed 42.5 AF.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second, (or its equivalent) and 4.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
