confirms the right to the use of water perfected under the terms of Permit S-23739. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point of diversion from the source. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: COAST FORK WILLAMETTE RIVER, A TRIBUTARY OF WILLAMETTE RIVER

PURPOSE OR USE: MAINTENANCE OF LOG POND, MAINTENANCE OF RECREATION & FISH CULTURE POND, CONSTRUCTION UNDER APPLICATION #R-30161, PERMIT #R-1774

MAXIMUM RATE: 0.77 CUBIC FOOT PER SECOND (CFS); BEING 0.75 CFS FOR MAINTENANCE OF LOG POND, AND 0.02 CFS FOR MAINTENANCE OF RECREATION AND FISH CULTURE POND

DATE OF PRIORITY: JULY 27, 1955

The point of diversion is located as follows:

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The quantity of water diverted at the new point of diversion, shall not exceed the quantity of water lawfully available at the original point of diversion described as follows:

The water user shall operate and maintain the fish screen at the new point of diversion consistent with ODFW’s operational and maintenance standards. If ODFW determines the screen is not functioning properly, and is unsuccessful in working with the water user to meet ODFW standards, ODFW may request that OWRD regulate the use of water until OWRD receives notification from ODFW that the fish screen is functioning properly.

Water use measurement conditions:

- A. The water user shall maintain the totalizing flow meters or another suitable measuring devices, as approved by the Director, in good working order, at the new point of diversion.
- B. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.

The right to the use of the water for the purposes aforesaid is restricted to the lands or the place of use herein described.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered February 6, 2018, at Special Order Volume 107, Page 643, approving Transfer Application T-12624, and together with Certificate 93600, supercedes Certificate 26393, State record of Water Right Certificates.
