confirms the right to the use of water perfected under the terms of Permit S-12309. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point of diversion from the source. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: MCKAY CREEK, A TRIBUTARY OF THE UMATILLA RIVER

PURPOSE OR USE: IRRIGATION OF 1.5 ACRES

MAXIMUM RATE: 0.013 CUBIC FOOT PER SECOND, IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION, NE 1/4 NW 1/4, SECTION 21, T 2 N, R 32 E, W.M.; OR ITS EQUIVALENT IN CASE OF ROTATION, MEASURED AT THE POINT OF DIVERSION FROM THE SOURCES.

DATE OF PRIORITY: AUGUST 14, 1936

The point of diversion is located as follows:

Twp	Rng	Mer	Sec	Q-Q	Measured Distances
2 N	32 E	WM	16	NW NW	585 FEET SOUTH AND 840 FEET EAST FROM NW CORNER, SECTION 16

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use is as follows:

The quantity of water diverted at the new point of diversion, together with the quantity diverted at the old point of diversion, shall not exceed the quantity of water available at the original point of diversion.

The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording
