confirms a portion of the right to use the waters of MCKAY RESERVOIR, a tributary of MCKAY CREEK, for SUPPLEMENTAL IRRIGATION of 1.5 ACRES.

A portion of this right was perfected under Permit S-7400. The date of priority is JULY 1, 1924.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) provided further that the right allowed herein for supplemental irrigation shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed therein.

The water user shall comply with the terms and conditions of a valid Water Contract between the Bureau of Reclamation and the water user.

The point of diversion is located as follows:

The water user shall maintain and operate the existing measurement device and shall make such improvements as may be required by the Department.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered April 2, 2010, at Special Order Volume 80, Page 548, approving Transfer Application T-10782, and modifies a portion of the right perfected under Permit S-7400.

**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
