## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GORDON AND JULIE LARSON 24335 HWY 395 SOUTH CANYON CITY OR 97820

confirms the right to use the waters of CANYON CREEK, a tributary of JOHN DAY RIVER for SUPPLEMENTAL IRRIGATION of 5.7 ACRES.

This right was perfected under Permit S-8025. The date of priority is JUNE 24, 1927.

The amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.08 CUBIC FOOT PER SECOND.

The point of diversion is located as follows:

14 S	31 E	WM	35	SE NE	CANYON CREEK PUMP (NEW) – 140 FEET NORTH AND 190 FEET WEST FROM EAST 1/4 CORNER, SECTION 35

The use hereunder for irrigation shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent in case of rotation.

A description of the lands irrigated under the right hereby confirmed, and to which such right is appurtenant is as follows:

Water use measurement conditions:

- A. The water user shall maintain the totalizing flow meter or other suitable measuring device as approved by the Director in good working order at each point of diversion.
- B. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.

## NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The quantity of water diverted at the new point of diversion, shall not exceed the quantity of water lawfully available at the original point of diversion described as follows:

The water user shall operate and maintain an approved fish screen at the new point of diversion. If Oregon Department of Fish and Wildlife (ODFW) determines the screen is not functioning properly, and is unsuccessful in working with the water user to meet ODFW standards, ODFW may request that OWRD regulate the use of water until OWRD receives notification from ODFW that the fish screen is functioning properly.

To protect Canyon Creek water users, the watermaster staff must have access to the original (authorized) points of diversion to compare the amount of water that is available at the original points of diversion with what is being diverted from the authorized points of diversion. If access is restricted, a measuring device capable of continuous measurement and recording with telemetry may be required at the Berry Creek #2 point of diversion. The landowner will be notified by the Department prior to accessing the property. The landowner will provide the necessary information to access the property through the locked gates.

Watermaster office staff shall have unrestricted access during the irrigation season to the respective measuring devices at the authorized points of diversion.

The right to use water for any purpose is restricted to the lands or place of use herein described.

This certificate is issued to confirm changes in POINTS OF DIVERSION and PLACE OF USE, approved by an order of the Water Resources Director entered MAY 14, 2020, at Special Order Volume 116, Page 761, approving Transfer Application T-12718, supersedes Certificate 7692, State Record of Water Right Certificates.
