confirms the right to the use of water perfected under the terms of Permit S-20066. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point of diversion from the source. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: CALAPOOYA CREEK, A TRIBUTARY OF UMPQUA RIVER

PURPOSE OR USE: IRRIGATION OF 21.3 ACRES AND DOMESTIC EXPANDED AND LIVESTOCK

MAXIMUM RATE: 0.28 CUBIC FOOT PER SECOND

USE OF WATER FOR DOMESTIC EXPANDED AND LIVESTOCK USE UNDER THIS CERTIFICATE IS LIMITED TO A RATE OF 0.007 CFS AND ANNUAL VOLUME OF 2.0 ACRE-FEET.

DATE OF PRIORITY: JANUARY 8, 1951

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW



A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
