CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of BARNES BUTTE RESERVOIR, constructed under Application R-29611 and Permit R-1734, a tributary of OCHOCO CREEK, for SUPPLEMENTAL IRRIGATION OF 107.9 ACRES.

This right was perfected under Permit 23497. The date of priority is DECEMBER 10, 1954. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 284.2 ACRE FEET of stored water, or the equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other water right existing for the same lands, shall be limited to a diversion not to exceed 4.0 ACRE FEET per acre for each acre irrigated during the irrigation season of each year and shall be further limited to a total diversion not to exceed 284.2 ACRE FEET per year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.



This certificate is issued to correct a scrivener's error in the amount of water to which this right is limited. This certificate supersedes Certificate 94694 and describes that portion of water right Certificate 82268, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered December 18, 2019, and recorded at Volume 114, Page 296, approving Transfer Application T-13091.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
