PURPOSE OR USE: IRRIGATION OF 3.0 ACRES

A. The water user shall maintain the totalizing flow meter or other suitable measuring devices as approved by the Director in good working order at each point of appropriation (new and existing).

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

B. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.

The quantity of water diverted at the new point of appropriation (Well 6), shall not exceed the quantity of water lawfully

available at the original points of appropriation (New Well 1 and Original Well) described as follows:
