CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of WELL 2 (NEW) in the FORT ROCK VALLEY BASIN for IRRIGATION of 41.31 ACRES.

This right was perfected under Permit G-10701. The date of priority is NOVEMBER 3, 1983. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.517 CUBIC FOOT PER SECOND (CFS) or its equivalent in case of rotation, measured at the well.

The well is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acrefeet per acre for each acre irrigated during the irrigation season of each year.

A description of the place of use to which this right is appurtenant is as follows:

The quantity of water diverted at the new point of appropriation shall not exceed the quantity of water lawfully available at the original point of appropriation described as follows:

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The water user shall maintain a weir, meter or other suitable measuring device to keep a complete record of the amount of ground water withdrawn.

Water shall be acquired from the same aquifer (water source) as the original point of appropriation.
