CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ELSIE PORTER ROSS JOHNSON RT. 2, BOX 30 ECHO, OR 97826

confirms the right to use the waters of A WELL, a tributary of UMATILLA RIVER for IRRIGATION of 68.0 ACRES and SUPPLEMENTAL IRRIGATION OF 29.5 ACRES.

This right was perfected under Permit G-4561. The date of priority is APRIL 10, 1969. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.22 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right allowed herein shall be limited to appropriation of water only to the extent that it does not impair or substantially interfere with existing surface water rights of others, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
