CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JACK AND CHERIL HEAVILIN
 HC 61 BOX 9606
 SILVER LAKE, OR 97638

confirms the right to use the waters of WELL 1 AND WELL 2 within the FORT ROCK BASIN for IRRIGATION of 2.04 ACRES.

This right was perfected under Permit G-8849. The date of priority is FEBRUARY 27, 1980. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.03 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The quantity of water diverted at the new points of appropriation (wells) shall not exceed the quantity of water available from the original point of appropriation described as follows:

27 S	17 E	WM	16	SW NW	60 FEET NORTH AND 720 FEET EAST FROM THE W1/4 CORNER OF SECTION 16

Water shall be acquired from the same aquifer as the original point of appropriation.


When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate describes that portion of water right Certificate 88683, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered ~~_____ FEB 09 2022 _____~~, approving Transfer Application T-13246.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
