confirms the right to the use of water perfected under the terms of Permit G-10712. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the well. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: A WELL IN THE FORT ROCK BASIN

PURPOSE OR USE: IRRIGATION OF 30.9 ACRES

MAXIMUM RATE: 0.38 CUBIC FOOT PER SECOND

DATE OF PRIORITY: DECEMBER 15, 1986

The well is located as follows:

Twp	Rng	Mer	Sec	Q-Q	Measured Distances
27 S	13 E	WM	22	NW SE	10 FEET NORTH AND 1310 FEET EAST FROM SW CORNER, NWSE, SECTION 22

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

Water use measurement conditions:

- A. The water user shall maintain the totalizing flow meter or measuring device, as approved by the Director, in good working order, at each point of appropriation (new and existing).

**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.


- B. The water user shall allow the Watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the Watermaster shall request access upon reasonable notice.

Water shall be acquired from the same aquifer (water source) as the original point of appropriation.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered July 13, 2018 at Special Order Volume 108, Page 831, approving Transfer Application T-12730, and together with Certificate 93871, supercedes Certificate 66571, State record of Water Right Certificates.
