confirms the right to the use of water perfected under the terms of Permit S-24611. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point(s) of diversion from the source. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: A SPRING, A TRIBUTARY OF COLUMBIA RIVER

PURPOSE OR USE: POND MAINTENANCE

MAXIMUM RATE: 0.002 CUBIC FOOT PER SECOND AND SHALL NOT EXCEED 0.3 ACRE FEET DURING THE IRRIGATION SEASON OF EACH YEAR

DATE OF PRIORITY: NOVEMBER 23, 1956

A description of the place of use is as follows:

The water user shall maintain, in good working order, an in-line flow meter or other suitable device as approved by the Department, and shall keep a complete record of the amount of water used under each right for each month and shall submit a report by December 31 of each year, which includes the recorded water use measurements to the Department annually or more frequently as may be required by the Director. Further, the Director may require the water user to report general water use information, including the place and nature of use of water under the right.

The water user shall allow the watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.

The right to the use of the water for the above purpose is restricted to beneficial use on the place of use described. The use confirmed herein may be made only at times when sufficient water is maintaining instream flows.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to confirm a change in CHARACTER OF USE AND PLACE OF USE approved by an order of the Water Resources Director entered October 20, 2004, at Special Order Volume 62, Page 150, approving Transfer Application 7821, and together with Certificate 80995, supercedes Certificate 68382, State record of Water Right Certificates.
