## CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of GRANDE RONDE RIVER, TRIBUTARY TO SNAKE RIVER for IRRIGATON of 11.5 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Union County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 8, at Page 1. The date of priority is 1872.

The use is limited to 3.0 acre-feet per acre in any irrigation season diverted at a rate of not to exceed ONE-FORTIETH of a cubic foot per second per acre; or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The water use shall maintain and operate a fish screening and/or by-pass device as appropriate, at the point of diversion consistent with Oregon Department of Fish and Wildlife's operational and maintenance standards.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in the said decree.

Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to confirm a change in POINT OF DIVERSION and PLACE OF USE approved by an order of the Water Resources Director entered February 20, 2014, at Special Order Volume 91, Page 861, approving Transfer Application 11622, and together with Certificate 89097, supercedes Certificate 85560, State record of Water Right Certificates.
