CERTIFICATE OF WATER RIGHT

confirms the right to the use of water perfected under the terms of Permit G-10223. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point of diversion from the source. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: BOONE PARK WELL 2 AND CHURCH WELL

PURPOSE OR USE: MUNICIPAL USE

MAXIMUM RATE: 1.40 CUBIC FEET PER SECOND (CFS), FURTHER LIMITED TO 0.69 CFS FROM BOONE PARK WELL 2 AND 0.74 CFS FROM CHURCH WELL, NOT TO EXCEED A CUMULATIVE TOTAL OF 1.40 CFS

DATE OF PRIORITY: APRIL 14, 1983

The wells are located as follows:

A description of the place of use is as follows:

WITHIN THE SERVICE BOUNDARIES OF THE CITY OF AUMSVILLE

The water user shall maintain a totalizing flow meter, or multiple totalizing flow meters if necessary to measure the entire rate and volume of water appropriated. The totalizing flow meter must be maintained in good working order consistent with those standards identified in OAR 690-507-645(1) through (3). The water user shall keep a complete record of the amount of water used each month and shall submit a report which includes the recorded water use measurements to the Department annually or more frequently as may be required by the Director. Further, the Director may require the water user to report general water use information, including the place and nature of use of water under the right.

**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484 and ORS 536.075. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 183.484, ORS 536.075 and OAR 137-004-0080, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate within three months after issuance of the certificate.

The water user shall allow the watermaster access to the meters; provided however, where the meter is located within a private structure, the watermaster shall request access upon reasonable notice.

The use of water under this right shall be limited to appropriation of water only to the extent that such appropriation does not interfere with or deplete the flow of Mill Creek or any tributary thereof; any depletion will require the well or wells to be shut down, since Mill Creek and its tributaries have been closed to further appropriation, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The wells shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works shall include an air line and pressure gauge or an access port for measuring line, adequate to determine the water level elevation in the well at all times.

The combined quantity of water diverted at the new point of appropriation, together with that diverted at the original points of appropriation, shall not exceed the quantity of water lawfully available at the original points of appropriation as described as follows:

Water shall be acquired from the same aquifer as the original points of appropriation.

This right is for the beneficial use of water.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described; however, water may be applied to lands which are not specifically described above, provided the holder of this right complies with ORS 540.510(3).
