confirms the right to use the waters of WELLS 1, 2, AND 3 in the JOHN DAY RIVER BASIN for IRRIGATION OF 1.8 ACRES, SUPPLEMENTAL IRRIGATION OF 52.4 ACRES AND AQUACULTURE.

This right was perfected under Permits G-11203 and G-11477. The date of priority is FEBRUARY 15, 1991. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 133 GALLONS PER MINUTE (GPM); BEING 60.9 GPM FROM WELL 1, 63.17 GPM FROM WELL 2, AND 8.4 GPM FROM WELL 3 FOR IRRIGATION OF 1.8 ACRES OR AQUACULTURE, or its equivalent in case of rotation, measured at the wells.
