The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the well(s). The specific limits and conditions of the use are listed below.

SOURCE OF WATER: STANFORD EAST WELL, STANFORD WEST WELL, CIRCLE #2 WELL, CELLAR WEST WELL AND CELLAR EAST WELL IN THE NORTH POWDER BASIN

PURPOSE OR USE: SUPPLEMENTAL IRRIGATION OF 432.9 ACRES

MAXIMUM RATE: 5.3 CUBIC FEET PER SECOND (CFS); FURTHER LIMITED TO 5.3 CFS FROM STANFORD EAST AND STANFORD WEST WELL, 1.56 CFS FROM CIRCLE #2 WELL, 0.66 CFS FROM CELLAR WEST WELL, AND 0.69 CFS FROM CELLAR EAST WELL, IN ANY COMBINATION TO EXCEED 5.3 CFS IN TOTAL.

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The quantity of water diverted at the additional points of appropriation, together with that diverted at the original points of appropriation, shall not exceed the quantity of water lawfully available from the original points of appropriation.

Water use measurement conditions:

- A. The water user shall maintain the totalizing flow meters or measuring devices, as approved by the Director, in good working order, at each point of appropriation.
- B. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.

The water shall be acquired from the same aquifer (water source) as the original points of appropriation.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm ADDITIONAL POINTS OF APPROPRIATION approved by an order of the Water Resources Director entered November 12, 2009, at Special Order Volume 79, Page 218, approving Transfer Application T-10837, supercedes Certificate 74070, State record of Water Right Certificates.
