CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOSEPH EDMONDS
314204 MCKAY ROAD
PRINEVILLE, OR 97754

confirms the right to use the waters of MCKAY CREEK, a tributary of CROOKED RIVER for IRRIGATION of 2.3 ACRES.

This right was perfected under Permit S-45561. The date of priority is June 9, 1980. The amount of water to which this right is entitled is limited to not more than 0.05 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:



This certificate is issued in accordance with OAR 690-380-6010 to describe the water right for a non-completed additional points of diversion approved by an order of the Water Resources Director entered December 5, 2001, at Special Order Volume 55, Page 1289, approving Transfer Application T-8642 and supersedes Certificate 76017, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described, and is subject to the existing minimum flow policies established by the Water Policy Review Board.
