CERTIFICATE OF WATER RIGHT

**This is to Certify, That** GEO. C. DURHAM, 122 F. 14th St., Portland, Oregon; G. H. DURHAM, Board of Trade Bldg., Portland, Ore., and GILBERT R. DURHAM, Grants Pass, of -----, State of Oregon, have ~~has~~ a right to the use of

the waters of Tennessee Creek, tributary of Quine's Creek, and Quine's Creek, for the purpose of Mining

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Douglas County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 11, at page 1; that the priority of the right thereby confirmed dates from 1865;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 65 cubic feet of water per second, for the period from November to May, inclusive, of each year.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:
