## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

SHOTGUN RANCH LLC 40791 SE SHOTGUN RD. POST, OR 97752

confirms the right to use the waters of CROOKED RIVER, TRIBUTARY TO THE DESCHUTES RIVER for IRRIGATION OF 17.6 ACRES.

This right was perfected under Permit S-27410. The date of priority is MAY 23, 1961. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.23 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the original point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

## Water use measurement conditions:

- A. The water user shall maintain, in good working order, a totalizing flow meter or other suitable measuring device approved by the Director at the new point of diversion (POD 3).
- B. The water user shall allow the watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.

The quantity of water diverted at the new point of diversion (POD 3), shall not exceed the quantity of water lawfully available at the original point of diversion (POD 4) located as follows:

The water user shall maintain and operate the fish screen and/or by-pass device, as appropriate, at the new point of diversion consistent with the Oregon Department of Fish and Wildlife's operational and maintenance standards.

This certificate describes that portion of water right Certificate 95555, State Record of Water Right Certificates, NOT22 odified by the provisions of an order of the Water Resources Director entered \_\_\_\_\_\_, approving Transfer Application T-13890.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
