CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CLARK CHASTAIN  
RT 1 BOX 32  
HALSEY, OR 97348

confirms the right to use the waters of a WELL in the CALAPOOIA RIVER BASIN for IRRIGATION of 15.6 ACRES AND 12.0 ACRES OF SUPPLEMENTAL IRRIGATION.

This right was perfected under Permit G-2212. The date of priority is JULY 31, 1962. The amount of water to which such right is entitled is limited to an amount actually used beneficially used for said purposes, and shall not exceed 0.290 CUBIC FOOT PER SECOND (CFS), being 0.16 CFS for irrigation, and 0.13 CFS for supplemental irrigation, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
