CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of FIFTEENMILE CREEK, TRIBUTARY TO COLUMBIA RIVER for IRRIGATION of 39.5 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Wasco County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 7, at Page 406. The date of priority is 1869.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.0 ACRE FOOT PER ACRE DURING ANY 30 DAY PERIOD UP TO JULY 1 OF EACH YEAR AND THEREAFTER NOT TO EXCEED 0.75 ACRE FOOT PER ACRE DURING ANY 30 DAY PERIOD; PROVIDED THAT THE TOTAL QUANTITY OF WATER DIVERTED DURING THE IRRIGATION SEASON SHALL NOT EXCEED 3.0 ACRE FEET PER ACRE; AND PROVIDED FURTHER THAT THE RATE OF FLOW SHALL NOT EXCEED ONE-FORTIETH OF A SECOND FOOT PER ACRE AFTER JULY 1, or its equivalent in case of rotation, measured at the point of diversion.

The points of diversion are located as follows:

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The water user shall maintain and operate the existing measurement device and shall make such improvements as may be required by the Department.

The water user shall maintain and operate fish screening as required by the Oregon Department of Fish and Wildlife operational and maintenance standards.


The diversion of water under this right for 38.5 acres transferred upstream is limited to times when instream water right certificates 59678 and 64744 are met, as measured at the gaging station (Fifteenmile Cr. Near The Dalles, #14105550) operated by Oregon Water Resources Department. When the instream water rights are not met at the listed gaging station, the water user may pump up to 0.76 cubic foot per second of water (Certificate 48907), which can be used to irrigate the 60.5 acres of 1861 priority (Certificate 48907) and the 38.5 acres under this right. In order to offset times when the water flow oscillates back and forth between meeting and not meeting the instream water right, a 7-day running average will be used to calculate the instream water right flow for purposes of limiting or allowing water use under this condition. Should the Watermaster during regulation of water call for 1869 priority date water rights to be shut off because of low creek flows, these 38.5 acres will not be irrigated until the watermaster allows further irrigation of 1869 rights.

If the water user of these 38.5 acres under this water right, leases or causes any water rights to be leased instream, a negotiation can occur between the user, Oregon Department of Fish and Wildlife, and Oregon Water Resources Department to alter the restrictions under the above condition.

Said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.

This certificate is issued to confirm a change in POINT OF DIVERSION and PLACE OF USE approved by an order of the Water Resources Director entered April 30, 2013, at Special Order Volume 89, Page 563, approving Transfer Application T-11121, supercedes Certificate 5678, State record of Water Right Certificates.
