The 155.0 cfs of water authorized under Permit S-49497 has been incrementally perfected under Certificates 96357, 96358, 96359, and 96360. Certificate 96357 authorizes the use of up to 39,3 cfs of water, being 18,54 cfs of water not subject to the conditions to maintain the persistence of listed fish species, and 20.76 cfs of water subject to the conditions to maintain the persistence of listed fish species. The full rate of water authorized for use under Certificates 96358, 96359, and 96360, is subject to the conditions to maintain the persistence of listed fish species as established by the Final Order for Extension of Time for Permit S-49497 issued August 24, 2012. These conditions will apply to any future superseding certificates related to Permit S-49497.

The maximum combined curtailment required under the conditions to maintain the persistence of listed fish species cannot exceed 20% of the combined rate subject to the conditions, being 27.29 cfs. Therefore, the 20.76 cfs under Certificate 96357, the 39.3 cfs under Certificate 96358, the 39.8 cfs under Certificate 96359, and 9.31 cfs under Certificate 96360 will never be curtailed as the result of this fish persistence condition.

The right granted herein is limited to the amount which can be applied to beneficial use and shall not exceed 39.3 CFS measured at the point of diversion, or its equivalent in case of rotation with other water users, from the Columbia River.

This right is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described; however, water may be applied to lands which are not specifically described above, provided the holder of this right complies with ORS 540.510(3).

This certificate is issued to clarify the conditions required to maintain the persistence of listed fish by an order of the Water Resources Director entered September _____, 2022 at Special Order Volume 125, Page 625-628 and supersedes certificate 93670.

This certificate was issued for a partial perfection of Permit S-49497 as described in OAR 690-320-0040 and by an order of the Water Resources Director entered March 16, 2018 at Special Order Volume 107, Page 773-774.
