CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ISIDOR B MEYER
POST, OR 97752

confirms the right to use the waters of CROOKED RIVER, tributary of DESCHUTES RIVER for IRRIGATION of 272.7 ACRES.

This right was perfected under Permit S-3972. The date of priority is JULY 24, 1918. The amount of water to which this right is entitled is limited to an amount actually used beneficially and shall not exceed 2.74 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the points of diversion.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent in case of rotation.

A description of the place of use to which this right is appurtenant is as follows:


