CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MEYER AND BROWN POST, OR 97752

confirms the right to use the waters of SOUTH FORK of CROOKED RIVER and CROOKED RIVER, tributaries of the DESCHUTES RIVER for IRRIGATION, LIVESTOCK AND DOMESTIC of 218.9 ACRES.

This right was confirmed by confirmed by decree of the Circuit Court of the State of Oregon for Crook County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 1, at Page 449. The date of priority is 1885 for 128.5 acres, and 1900 for 90.4 acres. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 2.756 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the points of diversion.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year (February 1 to December 1).

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer. The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
