This right was confirmed by decree of the Circuit Court of the State of Oregon for Crook County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 1, at Page 449.

Water use measurement conditions:

- A. The water user shall maintain the totalizing flow meter or other suitable measuring devices, as approved by the Director, in good working order, at each new point of diversion.
- B. The water user shall allow the watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the watermaster shall request access upon reasonable notice.

The water user shall maintain and operate the fish screen and/or by-pass device, as appropriate, at the point of diversion consistent with Oregon Department of Fish and Wildlife's operational and maintenance standards.

In order to prevent enlargement under Certificate 75947, the water right holder will plow a ditch along the cut off line to force water to the North Fork Crooked River.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.

This certificate is issued to confirm a change in POINT OF DIVERSION and PLACE OF USE approved by an order of the Water Resources Director entered December 18, 2019, at Special Order Volume 114, Page 56, approving Transfer Application T-12404, and together with Certificate 94489, supercedes Certificate 75947, State record of Water Right Certificates.
