CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JAMES A AND JANET L BISENIUS AND BIZZY B SEVEN LLC 29100 SW TOWN CENTER LOOP WEST, SUITE 100 WILSONVILLE OR 97070

confirms the right to use the waters of AN UNNAMED STREAM AND CORRAL CREEK, A TRIBUTARY TO WILLAMETTE RIVER, for IRRIGATION OF 9.8 ACRES.

This right was perfected under Permit S-17753. The date of priority is MAY 17, 1947 for 0.077 cubic foot per second, and MAY 28, 1947 for 0.045 cubic foot per second. The amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.122 cubic foot per second from unnamed stream and Corral Creek, or its equivalent in case of rotation, measured at the points of diversion from the streams.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall limited to a diversion of ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right and to which hereby confirmed, and to which such right is appurtenant is as follows:

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
