CERTIFICATE OF WATER RIGHT

confirms the right to the use of water perfected under the terms of Permit G-385. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the wells. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: WELL #1 IN THE SILVER CREEK BASIN

PURPOSE OR USE: SUPPLEMENTAL IRRIGATION OF 7.48 ACRES

MAXIMUM RATE: 0.09 CUBIC FOOT PER SECOND

DATE OF PRIORITY: APRIL 10, 1956

The well is located as follows:

27 S	15 E	WM	2	NW SW	WELL #1 - 2627.4 FEET NORTH AND 5215.45 FEET WEST FROM THE SE CORNER OF SECTION 2

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The quantity of water diverted at the new points of appropriation shall not exceed the quantity of water lawfully available at the original point of appropriation described as follows:

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The water user shall maintain and operate an in-line flow meter or other suitable device for measuring and recording the quantity of water diverted as required by the Department.


Water shall be acquired from the same aquifer (water source) as the original points of appropriation.

This certificate describes that portion of water right Certificate 94362, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered MAR 14 2023, approving Transfer Application T-13457.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
