Water shall be acquired from the same aquifer (water source) as the original points of appropriation.

This certificate describes that portion of water right Certificate 94365, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered MAR 1 4 2023 \_\_\_\_, approving Transfer Application T-13457.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
