This right was perfected under Permit S-34938. The date of priority is JUNE 25, 1970.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.02 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The points of diversion are located as follows:

The amount of water used for NURSERY OPERATIONS under this right, together with the amount secured under any other right existing for the same lands, is limited to 0.02 CUBIC FOOT PER SECOND and 5.0 ACRE FEET PER ACRE per year. The use for NURSERY OPERATIONS may be made at any time, during the period of allowed use specified above, that the use is beneficial.

For irrigation of CONTAINERIZED NURSERY PLANTS, the amount of water diverted under this right, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second and 5.0 ACRE FEET PER ACRE per year.

For irrigation of IN-GROUND NURSERY PLANTS, the amount of water diverted under this right, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second and 2.5 ACRE FEET PER ACRE during the irrigation season of each year.

For IRRIGATION OF ANY OTHER CROP, the amount of water diverted under this right, together with the amount secured under any other right existing for the same lands, is limited to ONE -EIGHTIETH of one cubic foot per second and 2.5 ACRE FEET PER ACRE during the irrigation season of each year.
