confirms the right to use the waters of COTTON WOOD CREEK for IRRIGATION of 45.7 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Grant County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 15, at Page 461. The date of priority is 1879.

The amount of water to which this right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed ONE-FORTIETH cubic foot per second per acre irrigated to June 1 and ONE-EIGHTIETH cubic foot per second per acre thereafter; further limited to 1.0 acre-foot per calendar month to June 1 and 4.0 acre-feet per acre during season April 1 to September 30, measured at point of diversion.

The points of diversion are located as follows:

**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The water user shall maintain the totalizing flow meter or other measuring devices, as approved by the Director, in good working order, at each additional point of diversion. The water user shall allow the Watermaster access to the meter or measuring devices; provided however, where the meter or measuring devices are located with in a private structure, the Watermaster shall request access upon reasonable notice.

The water user shall maintain and operate a headage, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The water user shall not construct, operate or maintain any dam or artificial obstruction to fish passage without obtaining approval from Oregon Department of Fish and Wildlife. The water user is hereby directed to contact an Oregon Department of Fish and Wildlife Fish Passage Coordinator, before beginning construction of any in-channel obstruction.


The water user shall maintain and operate fish screening consistent with current Oregon Department of Fish and Wildlife standards. Fish screening is to prevent fish from entering the diversion.

Said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for purposes aforesaid is restricted to the lands or place of use herein described.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered February 6, 2018, at Special Order Volume 107, Page 591, approving Transfer Application T-11972, and together with Certificate 93582, supercedes Certificate 36598, State record of Water Right Certificates.
