confirms the right to the use of water perfected under the terms of Permit G-10326. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the well(s). The specific limits and conditions of the use are listed below.

SOURCE OF WATER: A WELL IN THE PETERS CREEK BASIN

PURPOSE OR USE: IRRIGATION OF 8.2 ACRES

MAXIMUM RATE: 0.10 CUBIC FOOT PER SECOND

DATE OF PRIORITY: FEBRUARY 15, 1984

The well is located as follows:

26 S	18 E	WM	8	NW SE	WELL 2 (LAKE 50650) – NEW - 1347 FEET NORTH AND 2613 FEET WEST FROM SE CORNER, SECTION 8

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

Water use measurement conditions:

- A. The water user shall maintain the totalizing flow meter or other suitable measuring device as approved by the Director in good working order at each point of appropriation (new and existing).

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

B. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.

The quantity of water diverted at the new or additional point of appropriation, together with that diverted at the original point of appropriation, shall not exceed the quantity of water lawfully available at the original point of appropriation described as follows:

24 S	18 E	WM	35	SE SW	WELL 1A (LAKE 72) – ORIGINAL - 1250 FEET NORTH AND 1320 FEET EAST FROM SW CORNER, SECTION 35

Water shall be acquired from the same aquifer (water source) as the original point of appropriation.


The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm changes in POINT OF APPROPRIATION and PLACE OF USE approved by an order of the Water Resources Director entered MARCH 2, 2016, at Special Order Volume 98, Page 909, approving Transfer Application T-11989, and correcting order of the Water Resources Director entered JULY 20, 2016, at Special Order Volume 101, Page 458, and together with Certificate 91281, supersedes Certificate 86890, State Record of Water Right Certificates.
