CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

FRANCIS A KROUSE 15877 N APPLEGATE RD GRANTS PASS, OR 97527

confirms the right to use the waters of COVE CREEK, MYRTLE GULCH, and KROUSE RESERVOIR (constructed under Permit R-5611), a tributary of the APPLEGATE RIVER for SUPPLEMENTAL IRRIGATION OF 14.1 ACRES.

This right was perfected under Permit S-34984. The date of priority is JANUARY 27, 1970. The amount of water to which this right is entitled for the purposes aforesaid is limited to an amount actually used beneficially for said purposes and shall not exceed 0.38 CUBIC FOOT PER SECOND (CFS), being 0.28 CFS from Cove Creek and 0.1 CFS from Myrtle Gulch and reservoir, or its equivalent in case of rotation, measured at the point of diversion from the stream.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 4.5acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit R-5611 and further limited to the use of water from Myrtle Gulch and Reservoir on the 4.0 acres of supplemental irrigation located in the NE½ SE½ of Section 8, Township 38 South, Range 4 West, W.M..

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
