confirms the right to the use of water perfected under the terms of Permit S-51354. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point of diversion from the source. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: AN UNNAMED STREAM AND SANDY CREEK, TRIBUTARIES OF MIDDLE FORK COQUILLE RIVER

PURPOSE or USE: IRRIGATION OF 19.4 ACRES AND DOMESTIC USE FOR ONE FAMILY INCLUDING IRRIGATION OF NOT TO EXCEED ONE-HALF ACRE LAWN AND NONCOMMERCIAL GARDEN

MAXIMUM RATE: 0.0881 CUBIC FOOT PER SECOND, BEING 0.0851 CFS FROM SANDY CREEK FOR IRRIGATION AND 0.003 CFS FROM STREAM FOR DOMESTIC, OR ITS EQUIVALENT IN CASE OR ROTATION, MEASURED AT THE POINT OF DIVERSION FROM THE SOURCES. WATER MAY BE APPROPRIATED FOR IRRIGATION EXCEPT DURING THE MONTH OF OCTOBER

DATE OF PRIORITY: JUNE 20, 1990

The points of diversion are located as follows:

Diversion screening or fish passage facilities shall be operated to Oregon Department of Fish and Wildlife specifications.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484 and ORS 536.075. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 183.484, ORS 536.075 and OAR 137-004-0080, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate within three months after issuance of the certificate.

This right is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.

The right to the use of the water for the above purpose is restricted to beneficial use on the place of use described.
