confirms the right to the use of water perfected under the terms of Permit S-31708. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point(s) of diversion from the source. The specific limits and conditions of the use are listed below.

USE: SUPPLEMENTAL IRRIGATION OF 4.6 ACRES

LIMIT/DUTY: PORTION OF STORAGE FROM RESERVOIR CONSTRUCTED UNDER PERMIT R-4809

DATE OF PRIORITY: MARCH 15, 1966

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from storage from reservoir constructed under permit No. R-4809 and further limited to the use of stored water only on the lands described as supplemental; and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Water use measurement conditions:

- a) The water user shall maintain, in good working order, the totalizing flow meters, or, with prior approval of the Director, another suitable measuring device at each point of appropriation (new and existing).

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

- b) The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered July 31, 2018, at Special Order Volume 108, Page 999, approving Transfer Application T-12634, and together with Certificate 93901, supersedes Certificate 35191, State record of Water Right Certificates.
