a) The water user shall maintain, in good working order, the totalizing flow meters, or, with prior approval of the Director, another suitable measuring device at each point of appropriation (new and existing).

Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

b) The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.
