The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply or any prior right for the same land and shall not exceed the limitation allowed herein.

The right shall be limited to appropriation of water only to the extent that it does impair or substantially interfere with prior surface water rights as well as prior ground water rights of others.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Water use measurement conditions:

- A. The water user shall maintain the totalizing flow meters or another suitable measuring devices as approved by the Director in good working order at each point of appropriation (new and existing).
- B. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the watermaster shall request access upon reasonable notice.

The quantity of water diverted at the additional points of appropriation (Well #1 Upper Dam Well, Well #2 Middle Well, and Well #8 Lower Dam Well), together with that diverted at the original points of appropriation (Well #4 Stock Well and Well #7 Corral Well), shall not exceed the quantity of water lawfully available at the original points of appropriation (Well #4 Stock Well and Well #7 Corral Well).

Water shall be acquired from the same aquifer (water source) as the original points of appropriation.

The wells shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauges or access ports for measuring lines, adequate to determine the water level elevation in the well at all times.

The water user shall maintain weirs, meters, or other suitable measuring devices, and shall keep complete records of the amount of ground water withdrawn.

This right is for the beneficial use of water.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The right to the use of the water for the above purpose is restricted to beneficial use on the place of use described.

This certificate is issued to confirm changes in ADDITIONAL POINTS OF APPROPRIATION and PLACE OF USE approved by an order of the Water Resources Director entered MARCH 25, 2022, at Special Order Volume 122, Page 624, approving Transfer Application T-13690, supersedes Certificate 93875, State Record of Water Right Certificates.
