confirms the right to the use of waters as limited and conditioned below. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point of diversion from the source.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Union County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 8, at Page 1.

SOURCE OF WATER: GRANDE RONDE RIVER, A TRIBUTARY OF THE SNAKE RIVER

PURPOSE OR USE: IRRIGATION of 10.0 ACRES

MAXIMUM RATE: THE USE IS LIMITED TO THREE ACRE-FEET PER ACRE IN ANY IRRIGATION SEASON DIVERTED AS A RATE NOT TO EXCEED ONE-FORTIETH OF A CUBIC FOOT PER SECOND PER ACRE

DATE OF PRIORITY: 1872

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The right to the use of the water for above purpose aforesaid is restricted to beneficial use on the lands or place of use herein described and is subject to all other conditions and limitations contained in the decree.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered June 14, 2021, at Special Order Volume 120, Page 804, approving Transfer Application T-12740, and together with
