The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The Director may require the water user to install a totalizing flow meter or other suitable measuring device at each point of appropriation. If the Director notifies the water user to install a totalizing flow meter or other measuring device, the water user shall install such device specified by the Director within the period allowed in the notice. Once installed, the water user shall maintain the meter or measuring device in good working order and shall allow the Watermaster access to the measuring device.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
