confirms the right to the use of waters as limited and conditioned below. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point of diversion from the source.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Marion County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 18, at Page 437.

SOURCE OF WATER: NORTH SANTIAM RIVER, A TRIBUTARY OF SANTIAM RIVER

USE: IRRIGATION OF 29.8 ACRES

RATE: 0.37 CUBIC FOOT PER SECOND

DATE OF PRIORITY: MAY 14, 1909

NOTE: TO COMPENSATE FOR LOSSES BETWEEN THE POINT OF DIVERSION TO THE PLACE OF USE, AN ADDITIONAL AMOUNT NOT EXCEEDING TEN PERCENT IS ALLOWED.


And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.

**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered September 11, 2013, at Special Order Volume 91, Page 280, approving Transfer Application T-11545, and together with Certificate 88625, supersedes Certificate 54310, State record of Water Right Certificates.
