A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

b) The water user shall allow the Watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located withing a private structure, the Watermaster shall request access upon reasonable notice.
